Subject: MIS Service Data Entry Directive

Purpose

To provide additional guidance and clarification with respect to recent revisions to data entry and service delivery procedures in OSOS (aka NJCOS), the designated MIS platform.

Background

Due to recent DOL monitoring and to paraphrase the regulations regarding service delivery and exit from the program: Wherein any client that does not receive services (based on actual start date) within the last 90 days will cause the client to exit the program. Our practice of allowing the IEP/ISS and other non-training services to remain open longer than 90 days is no longer acceptable effective immediately.

Guidelines:

- IEP/ISS
 - You cannot leave an IEP/ISS or ANY non-training service open longer than 90 days. No exceptions and no extensions. Multiple IEP/ISS's are allowed, but only if a subsequent IEP/ISS is generated in the case file.
- Job Search (if entered)
 - Must be staff assisted: Provider staff must conduct the job search with the client, or do not enter it.
 - Open and close for the same day that staff conducted the search with the client.
 - o Can have multiple.
- Services (general)
 - Supportive services (with few exceptions) should be opened and closed for the same day.
 - o In order for a client to remain in program (not exited), you must provide a new service at a minimum every 90 days, or the client record will 90 day exit.
 - o Use all available services (both adult and youth), if provided.
 - Attached is a crosswalk for these services translating WIOA services to what is available in OSOS (or current MIS system).
- Training Services (only)
 - The only services that can remain open longer than 90 days (as prescribed by the training schedule).
 - Regardless of length, the service dates should match the projected dates included in the ITA
 or training contract. They may exceed the planned end date, but the planned end date
 should be changed once exceeded.
- Services NOT funded by WIA/WIOA Adult, Dislocated Worker, Youth or NEG funds:
 - These services should be entered with \$1 in the offering, and other amounts with NO actual
 costs entered. The funding source would be the same for these services as the rest of the
 funds for that particular client.
 - Services funded with money other than WIA/WIOA Adult, Dislocated Worker, Youth or NEG funds, should be funded with a \$1 (in order for OSOS to report them as a service), then use Min. Prog. Agreed to describe: the funding source, the amount and a short description of what the service was (if a description of that service is needed).
