1) CALL TO ORDER, confirmation of posting, roll call, Pledge of Allegiance

The meeting was called to order by Chair Jack Martin at 9:30 a.m. Staff confirmed the meeting had been properly noticed and posted in accordance with the Nevada Open Meeting Law. Roll call was taken and a quorum was present.

2) FIRST PUBLIC COMMENT SESSION

Hearing no comments, Chair Martin closed the Public Comment Session.

3) <u>DISCUSSION AND POSSIBLE ACTION: Approve the Agenda with inclusions of any emergency items and deletion of any items</u>

Jaime Cruz presented the WIOA Implementation Plan (p. 11-22) which he described as a repository to centralize tasks, timelines, responsible parties, and resources to ensure that WC in in compliance with new WIOA regulations effective July 1, 2015.

Commissioner Weekly inquired regarding the level of communication with DETR during these efforts, whereby Ardell Galbreth replied that staff meets with DETR at least weekly regarding various issues, WIOA strategy implementation as well as provides input to the various WIOA subcommittees of the Governor's Workforce Development Board, and works closely with the north.

Mr. Galbreth stated that DETR implemented the changes recommended by staff regarding the within state allocation formula for the Unified State Plan which is due to the U.S. Department of Labor by March 3, 2016. Staff is working on the Local Plan. Upon completion, the plan will be presented to the Board and LEOs for approval then submission to the state no later than July 1, 2016.

A motion was made by Commissioner Lawrence Weekly and seconded by Jerrie Merritt to accept and approve Workforce Connections' Workforce Innovation and Opportunity Act (WIOA) Implementation Plan as presented. Motion carried.
